Anti-ragging measures at campus

- Constitution of Anti-Ragging committee (ARC), Anti-ragging squads (ARS), Mentoring and Counselling cells (MC) in college as per guidelines.
- Informing to parents/guardians of all the students and explaining the adverse effect of ragging and anti-ragging measures that are initiated by the institution
- Conducting Joint Sensitization programmes (JSP), induction programmes and Counselling of freshers and seniors by a professional counsellor during the first two weeks of the academic year, conducted similar programmes in the hostels.
- Wide publicity to prevent, prohibit and punishment in respect of ragging.
- Taking affidavits and undertakings from students, parents and staff members in the proforma enclosed (AICTE web).
- Displaying anti-ragging posters on walls.
- Continuous monitoring in various places (campus) by installing CC TV cameras.
- Assigning one teaching and non-teaching faculty in every bus to monitor the students.
